INTRODUCTION

I wrote this summer-holiday serial for a number of reasons. First of all, *The Sunday Times** asked me to. The fee they offered would, I thought, do something to placate my bank manager, whose habitual whinings had lately begun to take on a nasty snarling note. And then I thought it would be a breeze, a dawdle, requiring no more serious effort than that of deciding which weekend to set aside for it.

I was wrong about that, of course. Once again I had forgotten the inescapable truth that there are only two sorts of literary task, the sort you know will give you a lot of trouble and turns out to do just that, and the sort you think you can sail through and turns out to give you a lot of trouble. Some writers never really learn the lesson however often and painfully it may be repeated, like the cheque-bouncer who keeps telling himself that *this* time he will get away with it. I myself have fallen into the

same mildly psychopathic error at least twice since, once over compiling a book of quizzes about drink and then again with choosing and introducing a daily poem for a popular newspaper. Yes, I agree heartily that it sounds like money for old rope.

But no accumulation of such reasons would have been enough to get me moving in any of these cases, certainly not on a sustained effort like this serial. Though a great and healthy driving force, the prospect of money needs supercharging with some degree of excitement or enthusiasm or at any rate a desire to take on this specific job and for the moment no other. And I happened to be able to provide that.

According to me, all writing is and should be to some extent a process of imitation: you like reading, you read a lot in general, you find yourself attracted to a particular kind of subdivision of literature, you read that kind intensively, you reach a stage where you begin to think perhaps you can contribute something of that kind yourself. That is probably what is meant by a tradition; it was certainly what got me started on writing in the distant past.

The reading on which my writing has been founded was always various, even indiscriminate, including as it did and taking seriously not only "straight" novels but adventure stories, ghost stories, spy stories, detective stories, science fiction. (I missed the Western, or rather confined my interest in it to the cinema.) By 1975 I had made some sort of contribution to all these genres, and more to the purpose I had recently (1973) published a detective novel, one of a particular type. It had a period,

inter-war setting, a complicated method of murder, a great-detective figure with eccentricities, including an obsession with jazz, and plenty of clues and misdirections on the classic model. It was also appropriately domestic, small-scale, involving a limited local community. When the serial was suggested there seemed to be a perfect opportunity for me to have a go at the opposite type of detective story, the one with large thriller or action elements and large forces involved—half Scotland Yard, hundreds of coppers, top political and professional brass, the whole nation holding its breath and the whole of London scared stiff as a mass-murderer prepares to strike again for some unknown but vast and terrible purpose—the crime of the century, in fact. And writing a serial of any sort was something else I had never done before.

As in other kinds of fiction, and not only fiction, an important part of the writer's strategy is to highlight what he thinks he knows about or is good at or anyway is interested in, and to bury or somehow get round the awful gaps in his abilities and stock of information. So here I made the most of my fascinated but amateur acquaintance with forensic psychiatry and my thorough grounding in detective stories. The one had a big say in establishing who might be and who could not be the master-criminal; the other was responsible for the rather heavy doses of inbred stuff about a series of "real" crimes that seemed to be developing along "fictitious" lines. Happily, though, I was able to build this into the plot and the solution in such a way as to make it an essential

guide to the identity of the villain and to the reason why he operated as he did.

What I had to conceal as best I could was my state of total inexpertness about anything that might be called police procedure, a field where my chief sources were foggy memories of novels by Agatha Christie and John Dickson Carr and more recent glances at "Z Cars" and other then current TV sagas. In retrospect I can see I was helped by the comparatively undeveloped state of common knowledge of the subject at the time. Even as recently as 12 years ago it was still just possible to seem to cover these matters without a research degree in them, and indeed to tackle any such topic unqualified by diplomas in applied ballistics, nuclear physics, computer science and the rest. Effrontery, that great unsung standby of every sort of novelist, the amiable implication that only a disastrously literal-minded type would insist on a detailed setting-out of the general picture so wittily hinted at, came to the rescue. At least nobody made any objections on that score, then or later.

To rephrase the position only slightly: the novelist is in the business of (among other things) getting away with pretending to know everything about what he only dimly and partially apprehends, and to know enough for his purposes about what he could never even begin to imagine. The procedure is known in the trade as the tip-of-the-iceberg con. I found writing *The Crime of the Century* a most valuable piece of training or refresher course in the basic fictional skills.

More specifically, the gymnasium of the exercise took many pounds of superfluous stylistic flesh off me. The

requirements of the format meant that I had to pour an immense amount of detail about suspects, their motivation, their movements, the ways in which their activities might or might not fit in with those of other characters and recent turns of the plot—all that—into an immovably restricted area of point. That in turn meant cutting the whole issue down to the bone, characterisations, descriptions of places and journeys, inner thoughts, any kind of feeling, whatever might be called extra. Well, being forced to dramatise absolutely everything must be good discipline for—here we go again—any kind of novelist.

When I look back now on the result, on what I actually wrote, my reactions are patchy, though not much more so than to any of my other finished products. Indeed I still cherish the verdict of the great Julian Symons that the working-out of the plot here, the actual detection, was reasonably watertight, something he had regretted not being able to say of *The Riverside Villas Murder*, my full-dress crime novel. I seem to remember he went so far as to commend the method used to pick up the ransom or blackmail payment under the noses of the police. To be honest, I thought it was not too bad myself.

A couple of other minor riddles give me some slight cause for complacency; I mention them briefly now to give the reader a hand in solving what I will admit is a pretty thorny puzzle. One is the reason why somebody who could have named the arch-criminal, and had a strong motive for doing so, didn't. The remaining point concerns the character Christopher Dane—a jolly handy invention of mine, by the way, bringing with him what

as far as I know is an original method of misdirecting the inquisitive reader. The extract from his current novel right at the beginning of the text is there to set going the apparent coincidence of the plot of that novel with the series of "real" murders starting at the same time, sure, and further to establish just for fun what a lousy writer he is. But it also conceals a hefty clue to the perpetrator of those murders.

The front-door buzzer sounded from the hall of the flat. Dane went out to the intercom.

"Yes?"

"It's me," said a steady feminine voice.

A short time afterwards, the owner of the voice was in the kitchen unloading groceries from a supermarket bag. Rosemary Dane, a long-legged dark blonde in her thirties, had not yet that day set eyes on her husband. This was customary. It was part of a much larger custom whereby, twice a year, he took rooms near their house in Hamilton Terrace and moved into them for a couple of weeks to do nothing else but eat, sleep and write a new

James Fenton mystery. Some of Rosemary's friends had queried that "nothing else" from time to time, but not to her face, and she herself never did, nor had she felt the need to do so. Fenton could not emerge effectively, the pair of them had proved, unless there were no children about, no visitors, no telephone, no mail and that was that.

The kitchen had been cleared up by the daily woman, who had seen Dane for a full thirty seconds the previous day, his first in residence, and might well have a similar experience on his last. Rosemary moved into the quite large and not very uncomfortable sitting-room, where the central heating was more than coping with the December cold. She put down on the sofa the current *Evening Chronicle*, an intruder tolerated purely for its crime reports, and waited.

Dane finished a sentence at the typewriter, came over and hugged her warmly yet absentmindedly.

"Everything all right?" he asked.

"Fine."

"What a dear little thing you are, in spite of being so tall."

"It's a feat, isn't it?"

After a pause, Dane released his wife, moved away and stared into space. Many women in this situation would have asked something like: "How's it going?" Rosemary did not, and never had; Dane often said it was the best single non-physical thing about her. Now, after more staring, he said:

"It's not going too well."

"Oh?"

"This bloody playing by the rules. Early mention of the criminal, so that roughly if it were a serial he'd have to come into the first installment—no real problem as long as it need only be a mention. All clues shared with the reader—if you can think of some. Sit down a minute. No vital coincidences—you can do quite a bit with non-vital ones. No secret passages, poisons unknown to science, twin brothers—yes, yes, yes. The really boring one is never being allowed to show what's in the criminal's mind even when it's nothing to do with the crime. You have to plug away with twitching mouths and fleeting expressions and . . . sharp looks."

"Agatha Christie showed a hell of a lot of what was in the criminal's mind in *The Murder of Roger Ackroyd*."

"That was in 1926. And Agatha's a law unto herself. I'm seriously thinking of chucking it in. That rule, I mean."

"I'd seriously think again about that. The Fenton fans would be certain to—"

"How many of those precious Fenton fans would notice the difference?"

"I've no idea," said Rosemary from the sofa. "But the reviewers would, and they'd stop calling Dane the last of the classic detective writers, which is one of your big selling-points. Surely."

"Mm." After circling the room, hands in pockets, Dane had come to where his wife was sitting. His glance fell to the newspaper, which he picked up with an uncharacteristically quick movement and began to read attentively.

Neither spoke for a time. Outside, a heavy lorry made

a thunderous gear-change, rattling the windows of the room.

"It's much noisier here than that place you took in the summer," said Rosemary as a reminder of her presence.

"A noise you can't do anything about doesn't count as a noise," said her husband without lifting his eyes from the print, then went on, evidently quoting, "A police spokesman stated this morning that there were some unusual features about the case which would be revealed at the proper time."

"Is that the girl on the common?"

"Yes. What unusual features? What proper time?"

"Raped, was she? I only glanced at it."

"No sexual interference."

"Why the fascination?"

"I hope they catch him, of course." Dane lowered the paper, but his eyes were still on it. "There's something horribly attractive about real crime which you just don't get at all in fictional crime. No way of doing it. A totally different kind of thrill."

"Is 'attractive' the word?"

"It isn't only nice things that attract people. We'd all have a much better time if it were different, I agree. Would we? I don't know. You'd better clear off, pet."

"All right, darling—see you tomorrow."

The newspaper report that had interested Christopher Dane had had a similar effect on a certain Henry Addams at an address in Bow, more marked, perhaps: it certainly took a more practical and laborious form. Addams, a small but strongly built person in his fifties, grey-haired

and bespectacled, read the report over his evening meal, to which he had sat down immediately upon arriving home just before six o'clock. After putting down his final cup of tea, he rose to his feet with decision and said to his wife:

"I think I'll go over to the study for a bit, dear."

"All right, dear. Will you be back for 'Coronation Street'?"

"I'll see," said Addams in his thin voice.

Taking with him the paper, and also a stiff-cover exercise book bought that day in his lunch-break, he left the house by the back door, crossed the strip of garden and unlocked the door of a prefabricated hut he had assembled himself some years previously. This was what he called his study; what he did in it he called working with his books. Once inside, he relocked the door, which was never unlocked except to allow him to enter and leave. The interior was sparsely but adequately furnished: a deal table, a battered chest of drawers serving as a kind of filing cabinet, a hard chair with a cushion on it, an easy chair, a two-bar electric fire. Thanks to this, and to the careful insulation of the door-frame and the two permanently shuttered windows, the place was comfortably warm in a few minutes.

Addams sat down at the table on the hard chair. With unhurried, precise movements he used a razor-blade and a steel rule to cut from the newspaper the report he had read earlier. Just as neatly, he gummed the clipping to the third page of the exercise-book (the first two would be needed for entering the contents) and added the date in a small upright hand. This done, he took from a shelf

a well-thumbed volume called *Compendium of Blood*, settled down with it in the easy chair, and turned to the chapter on Peter Kürten, the Düsseldorf sadist, arsonist and mass murderer. Henry Addams was soon happily absorbed.

Among the thousands of other people in London who read the report with particular care, five more might be mentioned. Four of them were unknown except in certain specialised quarters: Lucian Toye (as he was sometimes known), a highly qualified doctor, a devoted reader of Dane's James Fenton mysteries and a life-long misogynist; Evan Williams, a Post Office worker lately released after six years in a psychiatric hospital; Ronnie Grainger, a garage employee released about the same time after four years in prison for assault with a deadly weapon, his second offence under that charge; and Arthur Johnson, a watchmaker's assistant with an unreciprocated passion for a girl named Tessa Noble, a barmaid at his local pub.

The name of the fifth man was known throughout his profession and beyond. Sir Neil Costello, QC, had the previous months added a further legal triumph to an impressive record by securing the conviction of a murderer who, to all appearances, had been as innocent as the man in the moon. Costello had treated his colleagues' congratulations with reserve. He had maintained (so rumour said) that the old-fashioned criminal lawyer had lost any significance he might once have had, with acts of terrorism replacing the traditional privately motivated murder as a focus of public interest, and that it would be interesting to see if even a career like that of Jack the

Ripper would nowadays cause more than local concern.

It was far less widely known that Lady Costello, wife of Sir Neil, was an alcoholic.

Costello himself was a moderate, social drinker. That evening, in the bar of the Irving Club near Trafalgar Square, his tipples were chilled white wine. With his great height and abundant white hair, he stood out among the small group of members near the massive Edwardian fireplace. The talk—not surprisingly, since the combined ages of the four easily topped two hundred—was of “youth” and its ways.

The most eloquent was the Under-Secretary of State at the Ministry of Domestic Affairs, Dickie Lambert-Syme. If Costello could be called a caricature of a distinguished barrister, Lambert-Syme was equally a caricature of what a man so named ought not to look like: built like a heavyweight boxer but now running to fat, nearly bald head and heavy beard showing beneath the skin. With a favourite gesture, always used by the many people who did imitations of him, he banged his right fist into his left palm and growled.

“There are only two sorts—the bloody little fools and the rotten little swine. Both sexes. I deal with them every day. And every day I thank my lucky stars I’m not married.”

“My three don’t seem too bad,” murmured George Henderson, the shortest and thinnest of the group, a physique possibly earned by a lifetime of devoted cigarette-smoking.

“Give them their daily fix of Benedict Royal and they’re perfectly happy.”

"Oh, God." Quintin Young's handsome, lined face twisted into a passable tragic mask.

"Same with my two. Is he actually trying to make the most horrible noises anybody could think of or is that just the way it comes out?"

"Who is this Royal person?" asked Costello.

"Now then, Neil, you're not a judge yet," said Lambert-Syme good-humouredly.

"Benedict Royal is a very, perhaps I should say an excessively well known pop singer. And I'm not going to tell you what a pop singer is. I quite agree with Quintin about the noises he makes, but in fact—you're not going to like this—he's not a bad bloke."

"Oh yes he is," said Young. "He must be. It stands to reason."

"Have you ever met him?"

"He wouldn't be alive now if I had."

Lambert-Syme showed his huge teeth in a grin. "You of all people ought to know better than to go by appearance, Quintin. All that capering and yelling and the rest of it is just part of the act. When you talk to him he's quiet, behaves like a human being, bit over-dressed by our standards, sure, but . . . He's bright, too—does *The Times* crossword in fifteen minutes, if that's any guide. And I'll tell you something else between the four of us. He's helped us more than once at the Ministry."

"Like you're joking, man," said Henderson.

"Never more serious in my life, George. He gets around, you see. Knows about all sorts of places and people that don't exist for any of us. For instance, he hates drugs and at the same time he hears things about

where they come from. He had a hand in that big police haul in Knightsbridge a couple of months ago. And you probably remember we got the chaps who did the bomb at the Brazilian joint. We wouldn't have without young Royal."

Costello spoke in the mildly amazed pause. "Talking of persons who may or may not be horrible, or deemed horrible, I'm expecting Fergus MacBean any minute, so consider yourselves warned."

"I deem him horrible," said Young, "but if I may I'll stay around for a few minutes just to have a look at him."

"Dòn't you deem him off his rocker as well?" asked Henderson.

"No, just horrible. That's quite enough, though."

"Indeed."

"Can't stand the chap myself." Lambert-Syme looked at the watch on his hairy wrist. "Got to be off in a minute anyway—little champagne-party for two. Yes, he's a pain in the neck to us."

"I can't imagine what you want with him, Neil," said Young. "I should have thought you'd have had enough of him on that committee of his."

"I did, hence my resignation from it. But it's he that wants something with me. I suggested he came here so that at least I'd be on friendly territory. And I see he's come here. Now's your chance to slip away, Dickie."

Lambert-Syme made off in a wide sweep that took him well clear of the approaching figure. The Right Honourable Fergus MacBean, MP, would not have looked horrible to most observers; tall, square-shouldered, with fair hair brushed up from the brow, he was of attractive,

if slightly effeminate, appearance. What so many people deemed horrible about him was his views, or rather his view, incessantly urged: that every kind of convicted criminal should have a much worse time than at present, with the rope for murderers, castration for habitual sex offenders, prolonged solitary confinement for prison rioters, though not (to Costello's expressed surprise) amputation of the right hand for thieves. On all other matters he was an impeccable moderate, even liberal: satisfied with the state of the law regarding homosexuality, not specially concerned either way about pornography, positively hostile to racial discrimination—that last was a sore point for those of his fellow-MPs whose constituencies lay in urban trouble-spots while MacBean sat safely for a West of England agricultural area.

Costello introduced him, saying, "I don't think you know Quintin Young and George Henderson."

"By repute only." MacBean gave a warm smile and shook hands in turn in a slightly Germanic fashion. "Dr. Young. Dr. Henderson. Do say at once, either or both of you, if you've already put me down as a dangerous psychopath and/or a man on the immediate brink of a cerebral haemorrhage."

Among the three of them, the others managed a quite creditable burst of laughter. Costello went off to the bar. MacBean smiled again and said in his soft but clear voice, slightly marked by a Lanarkshire accent:

"Well, gentlemen, another wanton murder today, or yesterday rather: the stabbing in Barn Elms Park. You've probably laid bets I'd introduce the topic, but I'll go ahead regardless. The question's too important. Here's

this young girl been made away with in circumstances that hardly seem to suggest a family quarrel or a brawl in a bar or even robbery. Let's assume, at any rate, that this killing was premeditated. Would we be safe in assuming with total certainty that, were the death penalty for murder in force in the land, that consideration would have no deterrent effect whatever on any mental or emotional type of person? It's scarcely a new point, but it's not every day I meet a distinguished forensic psychiatrist, so I hope you'll forgive me if I ask you for your professional opinion."

Young sighed quietly. (Henderson had often heard him say how much he hated such interrogations outside working hours.) "Well, to begin with, *total* certainty on any matter concerning the mind is inconceivable . . ."

"I think that to concede so much concedes an all-important part of my case, Dr. Young—it would be false modesty on my part not to assume that you know well enough what my case is."

"Yes, I do. And it probably does. The concession you mentioned." Young gave a mildly despairing glance over at Costello, still waiting his turn at the crowded bar.

"If I may say so, I suggest you should not allow the matter to rest there. Assuming you do in fact concede my point, you ought to lend your name, with the weight it carries, to the work I'm trying to do."

"With what object? I don't see—"

"Let's start," said MacBean pleasantly, also with the air of starting something that would go on for quite a long time, "by considering the people whose business it is to control crime and criminals: the police. Their knowledge

that an apprehended murderer, instead of suffering his deserts, will be at large again within a few years is, my inquiries suggest, a substantial disincentive and discouragement to the detection forces. Their morale is low . . ."

Morale was certainly not high in the Murder Room at the headquarters of the Regional Crime Squad concerned with the Barn Elms Park killing. The officer in charge of the Squad, Detective-Superintendent Victor Ware, entered to find the officer in charge of the case, Detective-Inspector John Kemp, apparently in silent communion with his assistant, Detective-Sergeant Roger Masterton. The trestle table between them was littered with sheaves of typescripts and bundles of photographs.

"Sorry, I'm late," said Ware, striding in on short legs, then added, "but I can see I'd only have been in everybody's way. Where you fellows get all this . . . crackling energy from beats me hollow."

Kemp nodded his large dark head. "Yes, I could see how it would, sir. But we'd need more than energy to make any progress tonight. Or ever, possibly."

"What have you got?"

"That won't take long. Sergeant."

"I want it in full." Ware lit a cigarette with an angry movement.

"It still won't take long, sir. Sergeant."

"Bridget Ainsworth, sir," said Masterton. "Twenty. Stabbed five times in the back with an unusually thin blade: that's the autopsy—there was nothing there, at the scene that is. No assault. No theft. No evidence she put

up a struggle: nothing under her fingernails or any of that. No extraneous hairs or fibres on her clothing. Her parents say she said she was going to the movies locally, walking distance. None of the cinema staff remember her. Found near the road by a motorist just after seven A.M.; saw her lying there. The place is a couple of miles from her route to the cinema and back. Time of death, hour or two either side of midnight. Consistent with her going to the film, given a lift on her way home, stabbed in the car and dumped. Young: Then there's the straightforward sadistic sexual killing. Well, I suppose it isn't all that straightforward. What I mean is, the act of killing in itself is enough to . . . satisfy the chap's urge, so there's no intercourse or attempt at it. Then there are the people who are really mad . . .

Lambert-Syme: Unlike the models of sanity you've been telling us about.

Young: Sorry, I was thinking of the chap who decides the world is such a wicked and miserable place that he starts what he'd say was giving other chaps a merciful release. The trouble with—

Varga: [Inaudible]

Lambert-Syme: I'm sorry, Dr. Varga?

Varga: Just the obvious point that all what we

call violent crime is in essence this. A protest against the evils of our society.

Barry: That's not quite the same thing, is it, Dr. Varga? With respect, and even if it was, it would sort of cancel out on both sides of the equation and leave us back where we were. Go on, please, Dr. Young.

Young: I was going to say, the kind of murder I had in mind is usually a family affair. The fellow knocks off his wife and kids, plus any uncles and aunts who may be round the place, and then himself, typically.

Costello: So the variety that interests you, Quintin, is variety number two, what you called the straightforward sadistic killer.

Young: It's pretty rare, and they often don't stick to women. As I said, it's taking life they like. But yes, I favour number two at this stage. As among psychopaths, that is.

Costello: I suppose we can rule out these people who've written and telephoned in? The Dark December lot and the—what were they?—the British Liberation Army.

MacBean: We can rule out nobody, my dear Sir Neil. Nobody, seeing that the laws of this realm stand as they do.

Follett: [Erased from record]

Barry: Well, as regards that, I rather think we can, sir, for the moment anyway. Special Branch aren't exactly sitting on their bottoms, but they say it would be unique in a

big way, and my experience says the same. Girls, not politicians or the law or security. And the method, it's so dangerous. A bomb, gelignite, you're out of the way when it happens. No, somebody's trying to cash in is my guess. We won't forget it, but I'll start taking them seriously when they can show a connection, like telling us something only the killer could know. What do you think, Inspector Kemp?

Kemp: Oh. Oh, yes, Chief Superintendent, I agree. Mind you, I haven't had much to do with that side of life down where I am. Where I usually am.

Barry: Let's move on, shall we, gentlemen? This lull. Nothing last night. Not the end of it: he couldn't find anyone safe or he was otherwise engaged. It can't be the end, if only because of these . . . perishing letters. SOUTH. South what? Anybody . . . ?

Castello: South Yemen . . . Liberation Front?

Barry: I hope not, sir. That would mean, oh, another twenty before he's done. I'm afraid it looks like waiting and seeing there. Now the girls' surnames, the A-B-C question. To show they're linked? But any fool can see that without. Mind you, it could be chance.

Kemp: The chance of it being chance is of the order of one in three thousand, I'm told, sir.

Barry: That's not specially long odds in this kind of work. X-Y-Z would be a different matter. Well, a bit different.

Royal: Can I say something?

Lambert-Syme: Of course, Mr. Royal, please.

Royal: They're calling them the ABC Murders in the papers and places. That's what a book by Agatha Christie's called. I must have seen it on a news-stand somewhere.

Follett: It's been checked. No lead.

Royal: Are you sure, Commissioner? Just the title. And it's a book, isn't it? A story. Something someone made up. What I mean, what's been happening isn't . . . well, it isn't like it is. Is it, Chief Superintendent?

Barry: If you mean what I think you mean, no, it isn't.

Lambert-Syme: No doubt. Your department, Quintin.

Young: Yes, the idea that two people who aren't psychopathic individually behave psychopathically in concert, well, it doesn't seem to stand up. The view is that the senior partner is a genuine psychopath with some strong emotional hold over the junior partner. Who stops behaving psychopathically when separated from the senior partner. See Brady and Hindley. As for a couple of genuine psychopaths working together, it's unlikely. Individualistic lot, psychopaths.

Barry: So it's more likely to be one madman plus a chap who behaves like a madman than two madmen. I see.

Young: Well, not mad, but . . . Never mind.

Lambert-Syme: Any comments, Mr. Dane? Mr. Dane.

Dane: What? No. Sorry.

Henderson: Are you unwell, Mr. Dane?

Dane: No. No, I'm all right. Thank you.

"Are you really all right, Mr. Dane?" asked Henderson when the meeting adjourned for lunch.

"Yes, of course." Dane lowered his voice abruptly. "No. I'm not. I'm not ill, not physically, but I'm not all right."

"What's the trouble?"

"Oh yes. Christopher Dane understands human motives—I'm not talking about motives for murder and so on, just motives, motives for ordinary behavior. To the mad, other people are . . . a closed book. You might be a psychopath, of course, but I see no signs of it."

"You were making that distinction at the meeting. I couldn't see what the hell you were talking about."

"The psychopath understands other people when he bothers to; he just doesn't care about the consequences of his actions. Takes no thought for the morrow."

"Wasn't that chap Neville Heath, the one who cut those girls up, wasn't he a psychopath?"

"Oh, classic case."

"He took no thought for the morrow in a big way."

"And in smaller ways from puberty onwards. Take the question of his—"

"Look, don't let's take any bloody Heath questions at all," interrupted Henderson. "We came here to listen to this fellow's story, not Heath's."

"Sorry."

"You needn't apologise to me, Dr. Young. It's no waste of my time to be told on good authority that I'm not mad

and to be enabled to deduce that I'm not a psychopath. Especially after. . . . Anyway, there are two bits to this. I'm telling you the first because you may think that, not apparently the balance of my mind, thank God, but my judgment may be impaired, which is important with the second bit.

"First bit. I'm working on a new book at the moment. At least I was. The plot's about a psychopathic killer who goes round stabbing girls."

"Quite a coincidence," said Young brightly. "Is that all of the first bit?"

"Isn't it enough? Well, no, it's not all. I kept getting the feeling I was responsible in some way."

"You mean a burglar broke into your house to pinch the silver, started reading your manuscript out of curiosity, and ended up saying to himself, 'Hey, why am I wasting my time pinching silver when I could be out stabbing girls?' Or perhaps your wife or your charwoman. . . ."

"I know it was ridiculous of me."

"It doesn't sound all that ridiculous to me," said Henderson, "but then I'm not a student of the mind."

"Thank you. Ridiculous or not, I couldn't work and I couldn't sleep; all I could do was follow the case in the papers and on radio and television. Allow for that when I tell you the second bit. Here it is. One of the murderers is a member of this committee. Perhaps both."

"You must be . . ." began Henderson.

"Mad. Ha ha. Or joking. Not joking. That chap Royal, bright lad by the way, he got it right when he said—I've read the transcripts of your first session—

when he said whoever it was was doing a thriller. In a thriller, the guilty party would have to be on the committee, wouldn't he? In fact, by rights it ought to be Royal himself, because he suggested co-opting me."

"Let's get this straight." Young drained his tankard and made a face. "Now I'm not joking either. What fun if he happened to have no alibis for the vital times."

Young sipped his whisky with a thoughtful air.

"I do wish you'd go up to bed, dear," said Mrs. Addams to her husband. "What's the use of staying home if you don't go up to bed?"

"I'm all right, dear. I'm quite happy in front of the fire."

[General murmurs of agreement, commiseration, etc.]

Dane: May I ask Mr. Royal something? Did you have the impression that both Mr. Mannheim and you were being shot at, or was it only yourself?

Royal: Well, we were so close together you couldn't tell.

Dane: You were standing absolutely side by side?

Royal: Not standing—walking slowly, strolling. Anyway, what of it?

Lambert-Syme: Yes, could we get on, gentlemen? You've got the preliminary reports in front of you . . . Pauline Hodges . . . 26 years old . . . kitchen knife . . . A and part of an S . . . mm . . . large naevus on right cheek. Port-wine mark that is, isn't it? Poor little creature, she can't have had much of what makes life worth living. Would you take it from there, Bill?

Barry: The letters match with the others. S O U T H E A S is what we've got now, so it looks like we get the rest of the S and a T next time. South-east or south-eastern what? Anybody got any ideas? Nor me. London postal district? Suppose it is—where could that put us? He means he lives in SE5, say. Oh really? Or he's been to south-east Asia for his holidays. Interesting, eh? Nothing's emerged from any of the investigations. Oh, a bloody mountain's *emerged*, but none of it hangs together. No pattern.

Varga: Surely there are two things that now hang together: these murders and the so-called British Liberation Army. We should make a start to pay them this money.

MacBean: We cannot afford to submit to blackmail, Dr. Varga. If you pay the blackmailer, he comes back for more. His appetite grows with what it feeds on.

Varga: But lives are in danger, including our own lives. It's only a miracle that Mr. Royal escaped. The next one of us may not be so fortunate.

Follett: Dr. Varga, there's nothing whatever to suggest that any further attempts will be made on members of this Committee, because there's nothing to suggest that Mr. Royal was fired on in his capacity as a member, so to speak. A public figure—

Varga: I'm not going to die for your theories, Commissioner, I demand a police guard.

Follett: Look, if you knew how many . . . Tell him, Bill.

Barry: Effective round-the-clock protection for the lot of us would take over a hundred men, and at the moment I haven't got one to spare.

MacBean: Our safety lies with the safety of all, in catching these malefactors; I would not allow a single officer of the law to be deviated from that duty in order to look after me.

Royal: Right.

Lambert-Syme: Is everybody satisfied? You can always resign if you feel nervous, Dr. Varga.

Oh, we're combing the Irishmen, but I've no great hopes there. One thing is, all this TV coverage on Ulster and so on means a passable mimic could do a passable Irish accent.

Royal: I'd swear it was genuine, what I heard. Genuine Ulster, in fact.

Lambert-Syme: Isn't there anything positive we can do, anything at all? The Press are yelling their heads off and I can't say I blame them. The Minister's position is becoming—

Follett: The Minister can . . .

Costello: What about doubling the reward?

Follett: Or promising the killer immunity and a first-class flight to South America if he gives himself up.

Young: What's the position on discharged psychopathic patients, Bill?

Barry: Like the Irishmen, we're looking through them.

Varga: They should be left alone. They are victims of our diseased society.

MacBean: If our society is diseased, the respon-

sibility lies very largely at the door of such as you, Dr. Varga.

Varga: On the contrary, Mr. MacBean, of you and your kind . . .

After what seemed a very long time to most of those present, the Committee broke up, pledging itself to reconvene at 2:30. Lambert-Syme declared roundly that one should not keep a lady waiting and strode out. The others followed at a slower pace, Barry and Follett evidently in the deepest gloom. Dane approached Young and Henderson.

"I've found out one or two things. Care to hear them?"

"Very little risk of being recognised. His face isn't all that well known, and a simple false moustache and/or pair of heavy spectacles would fool any untrained observer. As regards alibis, that's where I'm hopelessly handicapped. I can't ask him and I can't ask the police to

ask him; I'm not, er, foolish enough to think I can go to them at this stage. There is one rather nice thing though. I read in the paper he was speaking at a dinner on the night when there wasn't a murder. What do you call that? An inverted non-alibi?"

"Those scenes of the crimes. Have you tried linking them up on the map into any kind of shape?" asked Young.

Dane gave him a grateful look. "I like the way you're thinking. Yes, but there's nothing there yet. No straight lines, unless possibly numbers two, three and four were intended to be one and he slipped up. No right angles—again, numbers one, two and three nearly were, and I was expecting something round about Battersea Park for number four, but then he shoots clear across London. If there is any sort of picture, it won't emerge until as near the end of the series as possible, and judging by the letters we're still a long way from the end. I wish I had any idea of the point of them. I've tried rearranging—"

"Now Costello." Young was watching Dane closely. "You can't find out where he keeps his car and you think his wife's an alcoholic, so she couldn't give him an alibi. Is that the lot?"

"I'm afraid so. Sounds pathetic, doesn't it? There's a little on a couple of the others. Lambert-Syme must be out of it. Public alibis for Buck and Collins, and he lives—"

"So his confederate does Buck and Collins."

"Oh, there can't be a confederate," said Dane, sounding quite shocked. "It must be all one chap. So: Varga—"

lives alone nowadays, and we agree on the hatred-of-women thing. Royal . . .”

“Royal’s good,” said Henderson, “because he set up that shooting incident himself to divert suspicion.”

“You two are really beginning to appeal to me.” Dane poured more wine. “A pity this Mannheim character will never be able to tell us anything about the circumstances of that. Your surprise is rather unflattering, Dr. Henderson. Even humble detective-story writers know that unconsciousness means concussion and concussion means amnesia.”

“I wonder if Royal knows that.”

“He couldn’t count on there being a bang on the head, could he? Unless of course he delivered it himself.”

“That would be nice.”

“I like the attitude to spaghetti here,” said Young, rolling some round on his fork. “They know it makes you fat and doesn’t do you any good, so they cook it like this to see you don’t eat much of it. Anything more on Royal?”

“No, except he didn’t want police protection this morning, because police protection means in effect police surveillance.”

"They're going to pay, are they?" asked somebody.

"What else can they do?"

"Just came through the letterbox."

"Still trying to reach the Minister."

"Going ahead regardless."

"Every minute counts."

Young turned to Dane. "So Barry was right up to a point, was he?"

"It's ridiculous. It doesn't fit. I can't understand it."

"I can understand enough of it. Things are what they seem to be, as they usually are."

"Family, friends, people at work?"

"Not really: I could improve on it quite a bit. But it'll do. I agree it's much less plausible than Possibility Three, whereby the murderer, having had it dinned into him by old Barry from the start that the Army can't be taken seriously until it can show some connection with the crimes, has managed to find them and has had a good twelve hours to let them know about the birthmark—not just for a joke. But we won't know exactly why until the finale."

"Possibility Four is the simplest and most plausible of the lot: Royal is and always has been the leader of the Army. I mustn't listen to you any more; you're driving me out of my mind. In the non-technical sense of the phrase, of course."

By nine o'clock that evening such preparations as could be made were complete. The walls of the headquarters were covered with a mosaic of large-scale maps of the Greater London area. On the ground, the largest force of

plain-clothes policemen, policewomen and auxiliaries ever assembled in the United Kingdom was standing by in vans, small trucks and similar vehicles, each with its two-way radio tuned to command frequency. But in maturity, and on that scale. . . ."

Barry made a face. "Even I wasn't quite thick enough to miss it altogether."

"Anyhow," pursued Follett, "what do you do in that situation? You can't contemplate murder even to save yourself from utter ruin, so you thump a fellow on the head as lightly as you dare, you—"

"You go straight to your Minister and make a clean breast of the whole boiling. What if that bloke Harding had had an abnormally thin skull? And what about leaving a mass murderer on the loose?"

"Of course, Bill, but all I'm saying is, I wish I could be absolutely sure I'd have done the right thing if I'd been as shocked and horrified and scared as Dickie must have been."

"I don't think I've ever seen a man more scared." Young reached for the claret. "So much so I guessed

what he must have been up to that night. Well, had a hunch."

Still rather belligerently, Barry said, "And what had he got in mind for the next act in the drama? More head-bashing as required?"

"I doubt if he had anything much," said Follett. "And we'll never know now. Fortunate Dickie."

Henderson spoke into another silence. "Doubly fortunate, in a way. Men of his age often survive their first coronary."

"Treble or triply or whatever it is fortunate," said Barry. Palatably, too, if possible. And I can't think of anybody better qualified than the old master-of mystery on my left."

"Thank you most kindly," said Dane, bowing in his chair. "Well, I'll tell you as much as I can, which won't be everything, because this was the sort of case that no one person could solve in its entirety. But I'll need refuelling first."

The brandy was passed to him. He took his time about pouring it and about clipping and lighting a cigar, clearly

elated at the prospect of delivering the kind of discourse he had so many times put into the mouth of James Fenton. The others recharged their glasses and sat back in what was almost a parody of expectation.

Then something comes along and triggers it off. What it could have been. . . . Look, shall I leave out all the probablys and possibly and tell it as a straight story?"

"What should this act be? It would have to be spec-

tacular, clearly. And destructive. Blowing up the Houses of Parliament? Too—ordinary. Not clever enough. Assassinating the Prime Minister? Good, but it's been done before. A series of atrocious murders? Nice, but also unoriginal, and so to speak inconclusive. So combine the last two. Clever in itself, and affording scope for further cleverness: in the course of the series of murders, various clues and misdirections will be fed to the investigators which they'll be too stupid to interpret or even recognise as such. Then the final blow, delivered as publicly as possible; not only for the spectacle, but so that there can be no doubt about who was responsible for the whole affair.

“One further requirement. He must be part of the investigation, firstly to keep safely ahead of it (he mustn't be caught until he's ready), secondly, to know just what clues to feed it, and thirdly to be able to enjoy at close quarters the sight of all those high-placed fools displaying their foolishness.”

With full production, Dane took a sip of brandy. “So, it might be a couple of years ago, he started preparing the ground. How could he be sure of being in on the investigation? Obviously not via the police. Then via the body with some responsibility for the police: the Ministry of Domestic Affairs. "Fergus Hume MacBean, I arrest you on the charge of attempted murder. I must warn you that. . . ."

"Murder? Of whom?"

"The Prime Minister. I . . ."

"Don't be a fool, man," was MacBean's reply, "the Prime Minister is as well as you are, though he wouldn't be if it weren't for me."

"What are you trying to say?"

"Didn't you see him about to go for the Prime Minister? No, I suppose you didn't; I got ahead of you going up the stairs and I obviously know my way about here rather better than you do."

"Are you suggesting that someone else was going to attack the Prime Minister at that precise moment?"

"Exactly so, and I had a pretty good idea who it was going to be, though I must admit that I expected it to be the other one. But you're wasting time here, man, his accomplice will have got away. Police morale is low enough already and you're going to look even sillier if you waste time arresting me. How will you take a headline in the papers saying 'MP prevents assassination of Prime Minister. Arrested by police while assassin's confederate escapes'?"

"Keep him here," snapped Barry, and hurried back to the lobby and the dense group near the door of the chamber. He pushed his way towards the centre where he recognised Kemp kneeling beside a body covered with a black cloth that looked as though it were normally used for a more active ritual.

"Ah, Chief Superintendent," said Kemp as he caught sight of Barry, "I'm afraid he's dead."

"Who, for God's sake?"

"The Under-Secretary, Sir."

"Lambert-Syme?"

"Yes, Sir."

Barry took over from the Inspector and cleared the lobby of the remaining people not connected with the police. The Prime Minister had insisted on carrying on with the business of the House and those members of the Press who were undecided as to the most rewarding place to be had their minds made up for them by the formidable array of officials who had now emerged. Among these was Follett who took charge.

Some time later in one of the security offices of the House, Follett and Barry were to be found looking distinctly uncomfortable.

"I've ordered a reconvening of the Special Committee," Follett muttered, "but I'm not looking forward to it."

"At least it will keep the Press at bay for a while."

"Long enough for us to find a culprit to present to them?"

"I don't know. MacBean seemed remarkably confident. What did you make of his story?"

"It sounded more convincing than anything any of the rest of us have come up with during this damned case. And we shall look prize fools if we hold him and he turns out to be right. Dane has had his intuitions and Royal has made some hints but Lambert-Syme is the first name that has been suggested with any conviction. And a lot of the details fit very well."

Follett had spent the last hour questioning MacBean who was now at the Yard making a statement but who had made it quite clear that he expected to be released as soon as he had done so. He had been left in no doubt as

to MacBean's notion of himself as the hero who had saved, if not the nation at least its political head and probably its democratic institution as well.

"Let's go over his case again. He claims that he disappeared without letting us know where he was because he suspected that there was someone from the Committee involved and since it might be the person who asked everyone to keep the Committee informed of our whereabouts he felt under no obligation to comply. He went away with his maps and discovered that the locations of the bodies found so far pointed towards the Houses of Parliament as the focal point. He reckoned that the complexity of the whole affair meant that something big was on and the biggest thing at Westminster is the Prime Minister. Lambert-Syme had been the person to suggest the Committee in the first place and since so many of the subsequent events seemed to assume a knowledge of what had gone on in the meetings of the Committee he had reluctantly concluded that Lambert-Syme was likely to be implicated."

"They were friends were they?"

"Well, MacBean claims that they were. They were certainly well acquainted but I seemed to remember Costello mentioning that he had had dinner with MacBean the night before the Committee was set up and that when MacBean arrived he had been talking to Lambert-Syme who went to great lengths to avoid having to meet his fellow MP."

"MacBean had a number of other fairly plausible supports for his theory," continued the Commissioner. "First, there was the attack on Sandra Phillips. Allowing

for the pauses in the tape and the state she was in, it's quite possible that her phrase 'he's ill, he must be ill!' referred to the first of her attackers and there is no doubt that Lambert-Syme has both looked and, been ill just lately. He's also the only person on the Committee who fits her description of being shortish, fat, fairly old, and with grey hair."

"But Lambert-Syme was almost bald."

"Yes, but if you remember she said that he was wearing a hat and so only the hair round the edge of it would be visible. And if you don't know that someone is bald you assume the part you can't see is the same as the part that you can."

"His suggestion that her remark about a house might be another reference to the House of Commons seems a bit far fetched."

"Yes, but he conceded that himself. And one has to admit that this illness has given Lambert-Syme a good excuse for being incommunicado quite a lot of the time lately."

"Then MacBean said that he was surprised that it was Lambert-Syme who should be the one to try to assassinate the Prime Minister at a specific prearranged time since he had more or less permanent access to him and could have done it at any time he wanted; that was why he expected the accomplice to be the one who actually carried it out—so that Lambert-Syme would be in a position to influence the inevitable shake-up from his position in the Ministry."

"He could still be right there, of course. After all Lambert-Syme didn't have any gun or weapon on him so

it doesn't look as though he was in fact going to do any harm to the Prime Minister."

"No, and the shot from MacBean could have frightened the real potential assassin away. The fact that MacBean was wrong in some respects doesn't mean that he isn't basically right in his conclusions. He says he was unsure as to whether the letters pinned to the bodies made a complete message or not—the second 'R' found on Colin Harding was only half a letter—but he rearranged the letters of 'south east rr' to make 'HOUSE,' 'START,' and the letter 'R.' This in combination with his findings on the map led to his deduction about the start of business at the House of Commons coupled with either a solitary 'R,' perhaps referring to Royal or an 'R' as part of another word in which case it might refer to Varga. If it was the latter he didn't think there was so much urgency since more letters would have to be found on another body first."

"Unless they were to be on the Prime Minister himself."

"Yes. He seems to have missed that possibility. He reasoned that both Royal and Varga are quite tall and thin and either could easily manage an Irish accent; indeed Varga seems to have a different accent depending on who he's talking to or what he's saying, and Royal is a professional performer. Of the two he found Royal particularly suspect because he hadn't come up with any theories of his own which was surprising for someone reputed to do *The Times* crossword in 15 minutes, and because he was known to have dealings with Lambert-Syme at the Ministry. Varga was also naturally suspect

because of his well-known views on the sickness and immorality of our society which would give him a motive as well. He attributes Lambert-Syme's behaviour simply to dejection, pointing out that by the law of averages there's bound to be a spy somewhere near the seat of power and it should be as unlikely a person as possible."

"Furthermore," continued Follett, "Lambert-Syme had proposed both Royal and Varga for the Committee in the first place, thus enabling him to keep in touch with either of them without suspicion being aroused."

"And that was the state of his deliberations when we saved him the trouble of bringing them to us himself by tracking him down ourselves. Later the message about the last one being at 2:30 which he overheard in the police car confirmed his theory especially as regards the 'START' and 'HOUSE' parts. Knowing the House as well as he does he knew exactly where to find the Prime Minister. As 2:30 came up he saw Lambert-Syme going up to the Prime Minister with what he described as a strange expression on his face and putting his hand into his pocket. MacBean says that he shouted out but there was so much background noise that the PM didn't notice so he took his revolver out of his pocket and shot at Lambert-Syme, not really intending to do other than stop him. Incidentally he has a licence for the gun and claims that he has been carrying it ever since Royal was attacked. With his views on the sort of treatment that should be meted out to murderers he is showing no sign of remorse. In fact he seems to think that a proper form of justice has been done."

"And Varga and Royal?"

"Waiting for us at the Ministry with the rest of the Special Committee, I hope."

EXTRACT FROM THE PROCEEDINGS OF THE FINAL
MEETING OF THE SPECIAL INVESTIGATORY
COMMITTEE.

Present: Follett, Barry, Kemp, Paynter,
Costello, Henderson, Young, Royal,
Dane, Varga.

Follett: And that, gentlemen, is the line taken
by MacBean. I'm sorry to put you in an
embarrassing situation [here he indicated
Royal and Varga especially] but as you
know we have all been under suspicion to
some extent.

Royal: Hence the protection?

Follett: Yes. I'm sorry to have to have used
some deception there.

Varga: Deception! I hardly think you managed
to deceive even this group of mindless
parasites. As for the idea that any self-
respecting party or country would want a
flat-headed illiterate charlatan like Lam-
bert-Syme as a defector, well, the whole
idea is quite bizarre.

Barry: May I ask, all the same, Mr. Varga,
where you were at 2:30 this afternoon?

Varga: If my bodyguard hasn't already told you
he's about as effectual as his employers. I
was at the House, of course. And a pleas-
ant afternoon to be spent watching the
Prime Minister squirm in the employment

debate was entirely spoiled by that idiot MacBean. I suggest that the whole thing was set up by the Prime Minister to get sympathy and slip out of his confrontation with the trade unions.

Barry: Mr. Royal?

Royal: Do I agree? Or are you asking me if I was at the House too? Your bloodhounds will no doubt give you the lurid details of my post-prandial activities—incidentally not those I should have indulged in if they hadn't been there. No, I wasn't at the House. I can assure you I have better things to do than go and watch famous people squirming. In fact I operate on the principle of getting other people to come and see me.

Paynter: Gentlemen, somehow we are expected to confront the nation—

Varga: The nation! Rubbish! You have only got to face your own compliant lickspittle bourgeois press.

Paynter: —with a plausible solution.

Varga: (Indecipherable)

Paynter: Very well. With the truth. It would seem now the murders are at an end—

Dane: Are they?

Paynter: Mr. Dane?

Dane: Well, they would be, no doubt, if the PM had been killed, but as it is—

Paynter: Quite so. Well, all the more reason for

us to confirm MacBean's theory or else replace it. Have you any views yourself, even intuitive ones—

Dane: As some of you know I've done a certain amount of prowling of late. For what it's worth to him—and before he says it himself let me say that I don't suppose it's very much—I don't think that Mr. Varga has anything to do with it. MacBean's line is a fairly convincing one. I was intrigued to find that apart from one letter (in the Swift tradition) the "SOUTH EAST RR" message is an anagram of "ARTHUR" and "TESSA," but it seems that Arthur Johnson has been in custody since his abortive attack on Tessa Noble and she has been back at work at the Fox and Grapes. Thank goodness the SOUTH EAST part doesn't seem to have any connection with the Queen's visit to South East Asia. But I'm afraid that I haven't really come up with anything. In fact about as far as James Fenton in his latest novel, which is page one.

Paynter: Has anyone anything more concrete to suggest?

Young: Have there been any results yet to my queries about discharged psychiatric cases?

Follett: Apart from a certain Evan Williams

who we can't seem to trace there doesn't seem to be a lead there, I'm afraid.

Young: I see. Well, in common with others of you I've been worried that one of those responsible must be on this Committee—though not necessarily by design. If it is by design it looks pretty certain to me that it must have been Lambert-Syme, as Mac-Bean suggests. But my real trouble is that I can't believe that there is even one psychiatric case of the right sort among us to account for the nature of the murders, except of course for the political one this afternoon. And the idea of there being two such people here is quite unthinkable.

Paynter: And you have been in a position to observe us all quite closely.

(At this point the meeting was interrupted by a telephone call for the Commissioner.)

Follett: Follett here. You have? Where? What? You have? I'll be right over. Well, gentlemen, talking of the devil it seems that part of our search at least is over. We have discovered Evan Williams in lodgings near Euston and found enough preliminary evidence to connect him with at least some of the killings. He denies it of course but I must leave you at once to go and question him.

Varga: With the usual methods?

Paynter: Please, Mr. Varga. Yes, of course,

Commissioner. I think we should stay here. Perhaps you will let us know of any developments as soon as you can so that we can tackle the Press.

(At this point Follett and Barry left the meeting.)

Dane: (Unintelligible)

Paynter: Mr. Dane?

Dane: Of course. What idiots we've been. Quintin Young has virtually solved it for us. It all fits, and we won't even have to arrest anyone.

Young: You mean that this Williams is Lambert-Syme's accomplice?

Dane: Oh, no. Lambert-Syme was intended to be the final victim all along. And MacBean intended to kill him from the start. But he had to weave a great pattern first so that he could do it publicly without it appearing to be murder. A sort of public execution. His connection with penal matters had enabled him to single out Williams from the records as a potential accomplice and then fit his whole scheme round the particular psychotic personality at his disposal. He hated Lambert-Syme both because his position at the Ministry made him a thorn in the flesh as far as his obsession with punishment methods was concerned, and also because that position was the very one that he coveted for himself but knew he could

never get. Everything in MacBean's account is consistent with his setting himself up with an opportunity to kill Lambert-Syme himself and yet still appear to be the hero of the piece. The clues he left had to be ambiguous because nobody else must be able to come to the correct conclusion about the House before him, and he had a fifteen-minute *Times* crossword man to contend with. But it still had to seem to have a pattern, and the Prime Minister had to seem to be the final target. With a combination of psychopathic killings and a political assassination who would be able to see the real motive. Moreover he had nothing to lose. I'm sure he gave that smile of his as he pulled the trigger.

Later that night, back in his house in St. John's Wood, Christopher Dane poured himself another Scotch.

"So, I was right," he said to the long-legged Rosemary, "and I didn't even need your alibi. But the idea really came from Young, and I suppose the setting up of a Committee was justified after all. Incidentally Williams fits Sandra Phillips's description of her first attacker so the taller one must have been MacBean himself. I suppose that a Lowland Scottish accent can easily be mistaken for an Irish one, especially when your mind is hardly on such things. Follett didn't have much trouble getting information out of Williams—I suppose it was an example of Young's psychopath not caring for the morrow.

But it does seem that he didn't know that his partner was MacBean, who had disguised himself at all of their meetings."

"I wonder if MacBean is pleased or sorry now there is no hanging."

"What a charming thought. Well, at least he saved me the trouble of finding a way of getting James Fenton on to page two of the new book. The Special Committee are allowing me to write the official version of the events.

"Hmm. I seem to remember you saying a couple of weeks ago that you found real murders more attractive. Still I don't see how you're going to produce your usual one a year."

"Oh, I don't know. Even if they don't invite me on to any more Special Committees at least there were enough red herrings and blind alleys in the present case for me to produce a different solution every year until MacBean is released."
